WARNING OF RISK & IMPORTANT INFORMATION

Golfing is an activity that challenges and engages the physical, mental and emotional resources of each participant. However, despite careful and proper preparation, instruction, medical advice, conditioning and equipment, there is still a risk of serious injury. Understandably, not all hazards and dangers can be foreseen. Risks inherent to golfing include poor conditioning or technique; being struck by a golf ball or club; being struck by lightning; slipping on wet surfaces; slips and falls associated with the choice of spikes; accidents with golf carts; inconsiderate play; horseplay; defects in course design; and premises defects and hazards. In this regard, it must be recognized that it is impossible for the Brooklea Golf and Country Club, Ltd. to guarantee absolute safety.

You should always stand away from and behind a player making a shot and be aware of the flight patterns of balls being hit by other players when you are around the greens and alongside the fairways. You should watch where you are walking or driving golf cart (i.e. crossing the highway, bridges, uneven terrain, sprinkler heads, surface imperfections, etc.); when playing a shot from a wrong fairway, ensure that the players playing that fairway are aware of the presence. Drive carefully and slowly in golf carts, as they are not toys. During a thunderstorm, do not ride in golf carts or stay outdoors; seek shelter in buildings, vehicles, or other locations that offer protection (avoid open fields, water areas, wire fences, overhead wires, isolated trees, and hilltops). Play should also be discontinued during a tornado warning (siren is sounded); seek shelter in the basement of the clubhouse or, if caught outside, in a ditch or low area.

GOLF CART USE/RENTAL AGREEMENT

APPLICABLE WHEN GOLF CARTS ARE RENTED

I represent that I am familiar with the operation of Brooklea Golf and Country Club's golf carts and agree to return said cart at the end of each play in the same good condition as received. I understand that golf cart drivers must have a valid driver's license to be eligible for cart rental. I agree to keep any cart rented to me in my custody while in use and not to sub-lease or re-rent the same cart. I further agree not to remove a rented golf cart from the property. I understand that no more than two persons and two golf bags are to be in a cart at any one time. I agree to abide by all rules and will assure passengers abide by rules as well.

I recognize and acknowledge that there are certain risks of physical injury to participants in this activity, and I voluntarily agree to assume the full risk of any and all injuries, damages or loss, regardless of severity, that my minor child/ward or I may sustain as a result of said participation. I further agree to waive and relinquish all claims I or my minor child/ward may have (or accrue to me or my child/ward) as a result of participating in this activity against the Brooklea Golf and Country Club, Ltd., including its officials, agents, volunteers and employees of Brooklea Golf and Country Club, Ltd.

I do hereby fully release and forever discharge them from any and all claims for injuries, damages or loss that my minor child/ward or I may have or which may accrue to me or my minor child/ward and arising out of, connected with, or in any way associated with this activity.
